

## **\*\*Terms and Conditions**

### **1. Duration / Early Bird Campaign Period**

The Early Bird Campaign shall be held from 8<sup>th</sup> August 2008 to 18<sup>th</sup> August 2008 ("the Early Bird Campaign Period").

### **2. Eligibility**

- All the investment must be within the Early Bird Campaign Period in order to be eligible for the draw.
- Employees of Public Bank Berhad and ING Insurance Berhad, their immediate families, affiliates, subsidiaries, related agencies and suppliers are not eligible to participate in the Early Bird Campaign.

### **3. Early Bird Campaign Mechanics**

Invest a minimum of RM 50,000 per policy in PB-ING All Weather Plan within the Early Bird Campaign Period. For every RM 50,000 invested per policy, the Eligible Participant will be entitled to ONE (1) entry. The Eligible Participant with more entries will have a higher chance of winning the prize.

Example:

RM 50,000 per policy = ONE (1) entry

RM 100,000 per policy = TWO (2) entries

RM 150,000 per policy = THREE (3) entries

The entries will be manually drawn by the Organizer at Menara Public Bank. For the avoidance of doubt, modification, cancellation, suspension or termination by the Organizer of this Early Bird Campaign shall not entitle for the Eligible Participant to any claim or compensation against the Organizer for any and all losses or damage suffered or incurred by the Eligible Participant as a direct or indirect result of the act of modification, cancellation, suspension or termination.

## **10. Miscellaneous**

- The Organizer reserves the exclusive rights to change, amend, delete or add to any of these Terms and Conditions without prior notice to the Eligible Participant and shall become effective on such date as the Organizer may determine. The Eligible Participant agrees to be bound by such amendments.
- By participating in this Early Bird Campaign, the Eligible Participant is taken to have read and agreed to the Terms and Conditions herein and shall adhere to all and / or any decisions made by the Organizer.
- In the event of any inconsistency, the English version of this Terms and Conditions shall prevail over all the other versions.
